DESTINATION DISCLOSURE STATEMENT: Sale, resale, and/or use of these goods is intended within the same country as the receiving address above. If resale and/or use is intended for any other country, or as part of a system intended for another country, the buyer must properly and completely inform MCLI of the end user prior to order being processed. MCLI expedites all orders as quickly as material availability and production levels will allow, but does not guarantee any specific date or accept purchase orders contingent upon guaranteeing a specific delivery/shipment date.

LOST AND/OR DAMAGED ITEMS DURING SHIPPING: MCLI relinquishes all responsibility regarding shipments after they have left the MCLI shipping dock. Items that are lost and/or damaged in the shipping process are the sole responsibility of the customer/recipient. Please let MCLI know if you wish to purchase insurance to protect your shipment.

OVERSEAS PAYMENT TERMS: Orders being shipped outside of the U.S. require prepayment via bank wire transfer before shipping. A \$40.00 bank wire fee will be added to all overseas orders.
